



Triodine-7[®]

Antiseptic / Disinfectant



- No DEA license required.
- Provides 2.4% Titratable Iodine, but less than 2.2% Molecular Iodine.
- Complies with DEA Iodine Regulation 21 C.F.R. §1310.12.
- Triple source Iodine Tincture: Iodine, Potassium Iodide and Povidone Iodine.
- More stable than 7% iodine.
- Provides liquid bandaging properties.
- Less attractive for illicit use.
- No “Hazmat” shipping fees for sizes under 1 gallon.

For use on Cattle, Sheep, Horses, Dogs and Swine for topical application on the skin to disinfect superficial wounds, cuts, abrasions, insect bites and minor bruises.

INDICATIONS: For use on cattle, sheep, horses, dogs, and swine. For topical application on the skin to disinfect superficial wounds, cuts, abrasions, insect bites and minor bruises.

DIRECTIONS FOR USE: If necessary, clip hair from area to be treated and cleanse with soap and water. Apply Triodine-7[®] with a swab.

CAUTION: Not for use in body cavities or deep wounds. Do not use on burns. Do not apply under bandage. Irritation may occur if used on tender skin areas. Avoid contact with eyes and mucous membranes. In case of deep or puncture wounds or serious burns, consult a veterinarian. If redness, irritation, or swelling persists or increases, discontinue use and consult a veterinarian.


STORAGE: Store at controlled room temperature between 15°-30°C (59°-86°F). PROTECT FROM LIGHT.
